



#### (1) FULL TIME JOB OFFER IN A POSITION ON THE RIGHT LIST

Short Term Stream – 2 years approval – occupation on STSOL (IELTS 5 overall minimum)

Medium to Long Term Stream – 4 years approval – occupation on MLTSSL (IELTS 5 in each component)

- Position offered must be in your field. At least 2 years of work experience in a similar role required;
- Minimum salary requirements + Market salary requirements;
- Labour Market Testing employer must advertise position for a minimum of 28 days;
- Company must be approved as a sponsor or apply for approval together with visa application training expenditure;
- Skilling Australians Fund: payment required from employers per year of visa nominated.

#### (2) PERMANENT EMPLOYER NOMINATION VISA

- Subclass 186 ENS Permanent Employer Nomination
- Subclass 187 RSMS Regional Employer
  - Temporary Residence Transtion Stream

Only after 3 years on a 482 and if occupation is on the right list at time of application; unless transitional arrangements apply

- Direct Entry Stream

Skills Assessment plus 3 years of work experience Skills Assessment not required for 187 Direct Entry (yet)

- Skilling Australians Fund: employers must make a one-off payment

# **GENERAL SKILLED** MIGRATION PROGRAM

Must have occupation on the right list applicable to each visa.



# 2 Lists: MLTSSL and STSOL

- (a) Skills Assessment with professional organisation;
- (b) Points Test minimum 65 points;
- (c) Expression of Interest request invitation via SkillSelect;
- (d) Visa Application.
